

THE EFFECT OF GLOBALIZATION AND DEMOCRATIZATION ON GENDER EQUALITY POLICY IN AZERBAIJAN

Introduction

Globalization may be indicated as a complex economic, political, cultural, and geographic process in which the mobility of capital, organizations, ideas, discourses, and peoples has taken a global form. This research deals with three major phenomena – globalization, democratization and gender equality, their interrelationship and impact on gender policies in the Republic of Azerbaijan. Although a lot of research has been done on globalization and democratization, but the gender aspects of these processes have not been sufficiently studied. Globalization and democratization can change the existing gender regimes in countries. But globalization itself contains contradictions and it initiates conflicts that can become sites of gender regime contestation. These contradictions can create new political and economical opportunities for women in both the private

and public spheres, the prospects for the establishment of democratization around the world as women are recognized as equal citizens with men. Globalization is spread by the idea of democracy and it helps people liberate from dictatorial burdens. The democratization is one of the important waves of globalization. The world has become more democratized during the past centuries. Democratic ideas, once established some progressive institutions of a society and it has positive impact on gender equality as these institutions make an effort to include all members of the society into the going process. The democratization brings the notions of equality; individual rights and citizens gain legitimacy of equal rights.

The globalization significantly changed the nature of the genders and led to a number of positive and negative consequences for society, which prompted to realize the importance of preserving and strengthening the spiritual and cultural traditions of the people. Many women in the world actively participate in social, economic and political activities. Globalization has the potential to be a powerful contributor to new opportunities for women to become more organized and demanding. The contribution of women to the financial well-being of the family, on the one hand, contributes to the growth of the woman's self-awareness, her equality in marital relations, on the other hand it causes the conflict between the genders, influences the position of women in the society.

The easy access to global networking system enables women to facilitate the transformation of their ideas cross the nations. The advancement of information technology is already benefiting women of democratic nations. However, these positive effects are still only potential and need to be unleashed. Therefore, there is much controversy surrounding the actual impact of globalization particularly in terms of gender equality.

Instruments of international law concerning women

Equal rights of women were stipulated in the international legal instruments after World War II. Establishment of the United Nations has led to the development of a comprehensive system of human rights. The UN Charter signed in San Francisco on June 26, 1945 can be considered the first international instrument based on the principle of respect for human rights. The Charter has obliged a sufficiently wide range of agencies and organizations to fulfill the obligations with regard to human rights (Ishay, Micheline R, 2004).

UN General Assembly has adopted a significant number of conventions and declarations regarding the human rights and in literature on the subject states that one of the most important principles underlying the European Convention is the principle of subsidiarity. There are three basic characteristics of the system envisaged by the Convention. First, the listed rights and freedoms are just the minimum standards. Member States may stipulate in national legislation or any

other international agreements a wide range of rights to be protected, rather than provided by the Convention, which in any case is not exhaustive. Second, the Convention does not contain uniform rules. It sets the standards of behavior, allowing the Member States freedom of selection of means for their implementation. Finally, as it has been repeatedly emphasized by officials of the European Union, first of all the national authorities themselves should find the right balance between the interests of society which are often varying considerably and the protection of the fundamental rights of individuals.

At the same time mechanisms to protect the rights of women were developed. On December 10, 1948 the Universal Declaration of Human Rights was adopted by resolution of the UN General Assembly. On the basis of Article 16 of the Declaration, men and women of full age, without any limitation due to race, nationality or religion, have the right to marry and to establish family. In this article, it was stipulated that marriage might be entered into only with the free and full consent of the intending spouses (Henry J Steiner and Philip Alston, 2000).

In today's world regardless of the level of development of countries, unbelievable processes take place in the context of globalization and democratization. As it has been mentioned above the impact of globalization on the women is not always positive, sometimes it makes them vulnerable in the context of global changes. Women make up the majority of the world's population, they play a key role in the different processes at the individual and community levels, the globalization has negative and positive impact on women. The negative consequences come from the lack of adequate social welfare programs. The globalization plays an important role in molding political, economic and social-cultural amplitude has drawn the women into the world-changing processes. The global decision makers manipulate their minds, interests and wishes. Globalization widens social and civilizational gaps and crisis and it ends in social contradictions. Today globalization simultaneously is opening up new opportunities for women in different spheres. While better-educated women in developing countries have prospered, majority of women in the world are still poor. The same process occurs for many women in newly democratizing countries (as in the post soviet republic).

Women of newly independent nations, more specifically post soviet republics are marginalized and kept isolated throughout century. The patriarchal nature of these societies normally constitutes the characteristic of the mainstream. The idea of man superiority and women's dependency to them has been consistent with traditional perspective of women position in these societies.

Timeline: Achieving gender equality in Azerbaijan

Azerbaijan is also a part of the international processes and Azerbaijan is affected by globalization too. The Republic of Azerbaijan, the first democratic and secular state of the Muslim world is a small but fascinating country at the crossroads of Europe and Asia. Azerbaijan's importance is much greater than its small size. The history of Azerbaijan includes several noteworthy events: it was the first national, secular, democratic and legal state and parliament in the East and in all the Turkish and Islamic world; and it had the first extension of suffrage to women, which made Azerbaijan the first Muslim country where men and women were politically equal. Saying Azerbaijan many people think only about the independence Republic of Azerbaijan (Northern Azerbaijan) but majority of Azerbaijan Turkic people live on the South bank of the Araks River, which is in present-day Iranian territory (also referred to as Southern Azerbaijan). Azerbaijan Turkic people living in south side of the river were allocated to Iran (according to the Treaty of Turkmenchay in 1828, as a result of wars between Russia and Iran in 1804-1813 and 1826-1828 years) taking the Araks River as their border. But Northern Azerbaijan the north side of the Araks River was included into the Russian Empire. Northern Azerbaijan, which became an independent country after the disintegration of the Soviet Union in 1991, unfortunately, Southern Azerbaijan, which is still the part of Iran Islamic Republic.

The major turning point is the beginning of the 20th century, when, in 1918, the National Council of Azerbaijan Democratic Republic "passed a law concerning elections to the Constituent Assembly that provided for direct elections, proportional representation, and universal suffrage—thereby making Azerbaijan the first Muslim country ever to enfranchise women" (Tadeusz Swietochowski, 1985: 144). Being the first Muslim country to grant equal voting rights to women, Azerbaijan further intensified the equal treatment of women in politics during the Soviet Union era.

Azerbaijan women have had a long way to emancipation and for two hundred years women (and men) fought for it. Towards the end of the XIX century, with the formation of the local, ethnically Azerbaijani, bourgeois business class influenced by the ideas of Russian and European secularism. Azerbaijani women started to enter the country's "public sphere through wage labor in the oil industry, garment workshops, charity activities, women's publications, women's clubs, and broad political groups that promoted women's literacy, vocational training, legal rights, and improvement in their overall status" (Nayereh Tohidi, 1998:140).

The traditional Azerbaijan culture continued to thrive during the Russian rule, with women "tending to the needs of family members and to traditional household tasks, with virtually no access to formal education and with relatively

little participation in public life” (Mehrangiz Najafizadeh, and Lewis A. Mennerick, 2003:33). The period of the Soviet Union’s rule further improved the conditions of Azerbaijani women, as through the egalitarian measures introduced by the socialist state, women were able to take broader work roles in the paid labor force and to gain “greater access to formal education and to political participation”—and the USSR “played a much more pronounced role in providing social services and in providing a social safety net for family and community maintenance” (Ibid., p. 39).

“Women of Azerbaijan has long a long history of struggle for equality and emancipation dating back to the years before the Bolshevik take over , Following this tradition, Azerbaijan women have been playing an active and responsible role in the transitional period. However, the emergency of war-stricken situation and concerns over primary needs and daily survival have preoccupied Azerbaijan women leaving little energy and enthusiasm for gender-specific issues. The low level of social awareness and understanding of how to protect democratic right women, the lack of political sophistication and lack of organizational skills, wide extend of conformism and limited individual initiative have slowed down the process of formation and maturation of a genuine women’s movement (Nayereh Tohidi, 2004:7).

Azerbaijani women have a better status and position compared to other developing Muslim Countries. At the present stage of development of national and international laws, the principle of gender equality was established within the framework of the system for protection of human rights and freedoms. The struggle for women’s equal political rights along with men started in European countries at the beginning of the 20th century. It should be emphasized that women in Azerbaijan gained the right to participate in the political life already in 1918. In comparison, women in Spain gained right to vote in 1931, in France in 1944, in Italy in 1946 and in Kuwait in 2006.

Azerbaijan is a secular country and religious values have not been fully integrated with states socio-political affairs. However, religion is one the defining factor in identifying the characteristics of power relation between women and men in this country. Majority of today’s Azerbaijani women are conscious of their own issues and able to make these choices and despite of enormous difficulties they have been making progress in struggle for equal rights.

Having common religion and sharing border with Iran Azerbaijan is different. The Islamic Republic of Iran continuously avoids Western influences while the secular Republic of Azerbaijan headed willingly to global integration and close ties with the West. Unfortunately, Azerbaijan has not been always able completely to escape of Iran’s influences and Islamic propogandas. Iran in gender policy discussions primarily focuses on women's position in Islam and to the

gender policy include how feminism have been shaped by the interplay between local and global factors. But the women's position in Azerbaijan do not share the same principals with Western concept of it, therefore there are clear distinctions between these two definitions leading us to conceptualize them differently. In the case of the Republic of Azerbaijan, social, political and economical conditions of post-Soviet era have been detrimental factors of Azerbaijan women's social status and their living conditions. Since its independence in 1991, people of Azerbaijan particularly women have faced new challenges, such as transition to capitalism, democratization and civil society building. Additionally during this transitional period, they have been struggling with complications of internal ethnic conflict and bloody war with Armenians over territorial disputes, which resulted in displacement of many Azerbaijan Turkic people.

“The post-communist “transition” has included the replacement of Soviet egalitarian discourse and equal rights for women (at least at a formal level) with varying degrees of Western liberalism, conservative nationalism and Islamism, all of which have significant gender implications” (Nayereh Tohidi, 2002).

Although Azerbaijan is a democratic country but “women's question” continues to be challenging since the dominant national discourse primarily regards women as mothers and guardians of national traditions. But the traditional roles of women (household cares) and men (providing the head of the family with economic prosperity) in the family were supplemented by modern social roles.

Majority Azerbaijan people, specifically Azerbaijan men see gender policy more Western, which understood anti-family. Many conservative people still believe that, the gender equality could be harmful to Azerbaijani traditional culture because it could lead to a growing gender consciousness and women's awareness. It encourages women's activism and demands for egalitarian changes and feminist values. People with conservative thinking believe that the debate on gender equality and their protests may extend to the women's movement in Azerbaijan. These people newly emphasize the women's traditional role in society and places women's political and civic activism within the limits of male-dominated nationalist parties.

Leading to transformation of feminism traditional forms and conditions to relatively modest nature, is capable of being responsive to the new challenges facing global feminist movement. The positive impact of globalization on gender issue in Azerbaijan includes, first, the stimulating and facilitating role that the international human rights or women's rights organizations have been playing in feminist debates such as transforming women's activism from initial nationalism in Azerbaijan toward feminist and democratic directions. Second, most women intellectuals, political activists and feminists in Azerbaijan have shown more interest on struggles and achievements of their activists in the West and in the

developing world. This new direction of feminism in Azerbaijan led to encouragement of distinguished intellectual women from different class to get involved with feminist activities.

The highly educated Azerbaijani women actively participate in international scientific events on various issues to establish international ties to strengthen their gender image. In the process of their contacts with the international community, especially with women's organizations they became more efficient and more conscious of women's rights. During the 1990s in Azerbaijan, women's local activism not only connected increasingly to transnational and global factors, they also experienced a shift toward de-idealization, de-radicalization and pragmatism. This new direction of feminism unsatisfactorily supported by predominantly, influential conservative male politicians. According to them, the women influenced by the "European model of woman" cannot be grateful for our family values and our women's primary identities are to be careful mothers and "good" wives. This type of femininity is associated in their minds with hostility to men and the family. There has been an ongoing effort on the part of Azerbaijani feminists to prove that women's quest for equality and freedom is not just Western. Their rightful demands are defined by state's gender policy, which has never been fully implemented.

Azerbaijan gender policy and National Legislation

The Azerbaijani government took the first steps towards mapping a national policy on "women's issues" by signing the UN Convention on the Elimination of All Forms of Discrimination against Women (CEDAW) on the eve of the Fourth World Conference on Women in Beijing in 1995. The Azerbaijani delegation actively participated in the Beijing conference and reaffirmed the recognition of women's rights within the general human rights framework. In 2000, Azerbaijan acceded to the Optional Protocol of CEDAW, thus recognizing the competence of the Committee on the Elimination of Discrimination against Women (the body that monitors states' compliance with the Convention) to receive and consider complaints from individuals or groups within its jurisdiction. The ratification of CEDAW is associated with improved conditions for women. And in 2001 Azerbaijan joined the Council of Europe, actively participating in the work of its Committee on Gender Equality. Azerbaijan has joined has officially adhered to several UN conventions concerning human rights and women's rights.

Majority of highly educated women with professional experience, are taking part in civil society building and democratization. They are fighting unemployment, political exclusion and social marginalization by participating in different sectors of social activities, which is a considerable progress in women's social participation. Calls for changes and endorsement of universal values of human

rights and democracy by true believers in Azerbaijan, including intellectuals and various Women's Groups became the new challenges of feministic movements today.

Along with many important events, the year of 1998 was one of great importance for the advancement of the concept of gender in Azerbaijan. "The State Committee on Women, created in 1998, is supposed to "oversee and coordinate" all programs and activities, including those of the women's NGOs dealing with women's status in Azerbaijan. The National Plan of Action on Women's Policy, which was drafted by this Committee and approved by the Cabinet of Ministries in March 2000, sets out priorities for achieving gender equality. It is not as strong as it could be because there are no clear mechanisms for monitoring implementation.

In 2000 the President issued a Decree on the State Women's Policy in the Republic of Azerbaijan. At the same time, the Cabinet of Ministers approved the National Action Plan on Women's Issues (2000-2005) and ordered the selection of gender focal points in all government institutions to bear the responsibility for promoting gender equality. The State Committee on Women's Affairs was established by Presidential Decree on 14 January 1998. The Committee was replaced with The State Committee for Family, Women and Children's Issues by another Presidential Decree on 6 February 2006. The Charter of the Committee was approved by Presidential Decree on 9 August 2006. The Committee is a central executive body (ministerial level), situated in Baku, the capital of Azerbaijan, and financed by state budget. The Committee is responsible for the implementation of state policy on family, women and children's affairs.

The Constitution of Azerbaijan guarantees equality and rights for all citizens; Article 25 specifically prohibits any restriction of these rights on the grounds of gender. Although equal rights for men and women are guaranteed under the Republic of Azerbaijan Constitution, gender inequality persists, specifically in the regions far from the capital, Baku. Principles contained in the Employment Code, the Penal Code and the Marriage and Family Code all stem from the Constitution, thereby further sanctioning equal rights and freedoms for men and women. Law on State guarantees of equal rights for women and men consists of 21 articles and was adopted on 10 October 2006. It aims to eliminate all forms of gender-based discrimination. It seeks to ensure gender equality in political, economic, social, cultural and other spheres. Additionally, the law guarantees all human rights for women as well as men.

The law on "Guarantees of Gender (Men and Women) Equality" that enacted in October 2006 seeks to eliminate "gender-based discrimination" while also containing clearly discriminatory provisions that take into account the "special nature of women", including different ages for marriage and retirement for men

and women; military service exclusively for men, as well as different punishment sentences and imprisonment regimes for men and women. The law prohibits sexual harassment, which in articles 2 and 3 is defined in detail. Articles 11 and 12 regulate employment situations if sexual harassment has taken place and ban persecution of the person reporting sexual harassment by the employer.

The Law on Prevention of Domestic Violence was adopted on 22 June 2010. It intends to prevent domestic violence in particular between close relatives, to mitigate the negative legal, medical and social outcomes of domestic violence for victims, and to provide legal and social assistance for survivors of domestic violence. It does not explicitly state that its aim is to protect women against domestic violence. However, it is clear that in most cases, women are the victims of domestic violence. The Law accepts the prohibition of discrimination against women as a core principle in the field of prevention of domestic violence. And it expressly names three types of domestic violence: domestic physical violence, domestic psychological violence, and domestic sexual violence (Law No. 1058-IIIQ of 22 June 2010 on Prevention of Domestic Violence). The most recent positive development in Azerbaijan began after the adoption of the Law on Domestic Violence in October 2010. Law also prohibits polygamy. The Penal Code also prohibits any attempt to oblige women to enter into marriage or polygamous relationships.

Articles 56 to 61 of the Family Code, which stipulate that both parents have the same rights and responsibilities in caring for and educating their children, covers parental authority. Nonetheless, traditional norms and culture restrict women in a subordinate role. The law on inheritance reflects legislation granting spouses equal property rights. It awards preference to the surviving spouse, thereby ensuring that the spouse receives shares equal to that of the children and parents of the deceased. Regardless of what the will of the deceased states, a portion of the inheritance must pass to the surviving spouse – and must equal at least half the share to which the spouse would be legally entitled. Widows are free to decide whether they wish to remarry and, indeed, who to wed. Concerning ownership rights, Azerbaijani women have the right to pursue economic independence. Access to land is a guaranteed right for all Azerbaijani citizens, regardless of gender. There are no legal restrictions on women's access to property other than land and no statutory limits on their access to bank loans. Both spouses have the same rights of ownership and tenure of the couple's joint property, whether such property was acquired with the husband or wife's income.

Conclusion and result

In order to change the current concept of feminism and increase women's potential to acquire more responsibility and opportunity, the local feminist NGOs must develop and promote comprehensive programs and plans aimed at empowering women's society and increasing their political and social awareness. Azerbaijan remains for many speculations as a society, which is dominated by the capitalization process than democratization.

However, the importance of “awareness” in the process of empowering women and organizing them to overcome violation of Women’s Rights, the quest for legal protection of organizations that are actively involved with women’s improvement plans is extremely critical to their gender - related challenges. Empowerment of deprived females from their legitimate rights is not an easy task, however, considering its significance to overall objective of feminism in Azerbaijan; its seriousness became necessary to female activists.

Azerbaijan women have to be aware of traditional norms, customs and any things that could marginalize female societies. It is not secret that religious factors influence women’s desire to practice religious customs, which make most of political leaders in nationalist parties to adopt more restrictive gender policies. Major women are nor aware of their rights and they have to be informed of their rights and challenges by the activist feminist women. According to the Constitution of the Republic of Azerbaijan every individual is entitled for certain rights and these rights will not be handed to them easily. Women will have to get involved with programs designed to empower them politically and socially, enabling them to take responsibility of leading their own feministic movements. It is unlikely to think that men will abandon their current superior position and willingly surrender to women’s demand for equal rights, there for awareness is critical to feminism movement, considering the magnitude of their challenges, particularly in patriarchal societies.

Future steps in the field of protection of women rights have already been defined by the Government. In this regard, as stipulated in “Azerbaijan 2020: Look into the Future” Concept of Development, Family strategy, Child Strategy, and Child Code will be adopted. The newly adopted Development Concept “Azerbaijan 2020: into the Future” once again proved that the gender problems remain in the center of attention. A number of such special documents as a “National Action Plan on Gender Equality”, “Azerbaijan’s family strategy”, creation of the system to monitor evasion of education and early marriages are being worked out for the implementation. It has become a practice to integrate gender equality perspective into domestic legal research, legislation or to solve social problems.

Azerbaijan closely cooperates with international bodies, and international standards are being followed by legislation in the field of protection of women and children rights. The legislative, judicial, administrative measures that the Republic of Azerbaijan had adopted during the last decade give outstanding results. As confirmation of the above, it should be noted that there are no sectors to which women have not c have decreased. International agreements and conventions set standards for gender equality and make governments accountable for the legal and political commitments they have made. They still remain important in providing gender equality and women empowerment.

Qloballaşma və demokratikləşmənin Azərbaycanda gender bərabərliyi siyasətinə təsiri

Məqələdə demokratikləşmə , qloballaşdırma prosesləri və Azərbaycanda gender bərabərliyi siyasəti ilə əlaqədar məsələlərə aydınlıq gətirilir. Gender bərabərliyi bu gün dünyada çox mühüm əhəmiyyət kəsb edən məsələlərdən biridir. Cinslər arasında bərabərlik insanın başlıca hüquqlarından biri kimi qəbul edilir. Demokratik cəmiyyətlərdə gender məsələlərinə xüsusi əhəmiyyət verilməsi heç də təsadüfi deyil. Həqiqi demokratiya qadın və kişilərin cəmiyyətdə bərabər hüquqlu iştirakını tələb edir. Demokratikləşmə və qloballaşma gender bərabərliyi siyasətinin inkişafına təşviq də edə bilər, qadınlar üçün yaxşı nəticələr verməyə də bilər. Müəllif iddia edir ki, demokratiya və qloballaşmış inkişafdan genderlər bərabər faydalanmırlar. Demokratiya və qlobal iqtisadiyyatın genderlərə fərqli təsirini aradan qaldırmaq üçün aşağıdakıları nəzərə almaq lazımdır: a) qadınların siyasi hüquqlarını gücləndirmək, b) gender bərabərsizliyi barədə məlumatlandırmanın təşviqi və c) qloballaşmış inkişafın qadınlara mənfi təsirləri. Azərbaycanda qadınların hüquqlarının genişləndirilməsi, cəmiyyətdə fəallığının artırılması məsələlərinə daim yüksək diqqət və qayğı göstərilir.

Bununla bağlı möhkəm hüquqi baza ilə yanaşı, ciddi siyasi iradə mövcuddur. Hazırda ölkəmizdə müxtəlif sahələrdə aparılan islahatlar, vətəndaş cəmiyyətinin formalaşmasında vətəndaşların fəallığının artırılması yolunda görülən işlər qadınların cəmiyyətdəki rolunun artırılmasını da təmin edir. Demokratik cəmiyyətlərin ən mühüm prinsiplərindən biri olan gender bərabərliyi, kişi və qadınlar arasında real bərabərliyin təmin olunmasında, cinsi istismarı düşüncənin qarşısının alınmasında, gender əsaslı diskriminasiya və zorakılığın qarşısının alınmasında bütün ictimai institutların və digər qurumların imkanları səfərbər olunmalı, praktik addımlar atılmalıdır.

РЕЗЮМЕ

Влияние глобализации и демократизации на политику гендерного равенства в Азербайджане

В статье разясняются вопросы, связанные с политикой демократизации, глобализации и гендерного равенства в Азербайджане. Гендерное равенство является одним из наиболее важных вопросов в современном мире. Гендерное равенство считается одним из основных прав человека. Не случайно в демократических обществах особое внимание уделяется гендерным вопросам. Подлинная демократия требует равного участия женщин и мужчин в обществе.

Демократизация и глобализация могут также способствовать разработке политики гендерного равенства и могут не дать хороших результатов для женщин. Автор утверждает, что гендеры не равно пользуются демократией и глобальным развитием. Для устранения влияния демократии и глобальной экономики на гендерные аспекты необходимо учитывать следующее:

- а) укрепление политических прав женщин;
- б) Повышение осведомленности о гендерном неравенстве
- в) Неблагоприятные последствия глобализации для женщин.

Азербайджан всегда уделял большое внимание поощрению прав женщин и расширению их участия в жизни общества. В связи с этим наряду с прочной правовой базой существует и серьезная политическая воля. Реформы, проводимые в настоящее время в нашей стране, и усилия по увеличению активности граждан в формировании гражданского общества также помогают повысить роль женщин в обществе. Одним из важнейших принципов демократически обществ должно быть использование потенциала всех государственных учреждений и общественных институтов для обеспечения гендерного равенства, реального равенства между мужчинами и женщинами, предотвращения сексуальных домогательств, дискриминации и насилия по половому признаку.
